# C. Monthly/YTD revenue and expenses

Jenn Nguyen reported on the monthly revenue and expenses for May 2024. Fund 870's starting balance was approximately \$11.6M. The Agency received \$2.8M in revenue. Expenditures were \$964k, leaving the ending balance at \$13.46M. Fund 871 had a starting balance of \$9.17M. There was \$12.6k in revenue and expenditures totaled \$161.4k. The ending balance for fund 871 was approximately \$9.02M. The Agency's combined cash position for the month was approximately \$47.5M. As of 7/10/24, the Agency's combined cash position was approximately \$47.3M.
